- 5. WELCOME TO CITIZENS MAYOR PRO TEM, BUTCH LYNCH No citizens were in attendance.
- 6. APPROVAL OF AGENDA BY COUNCIL The board moved on to the approval of the agenda. Commissioner Hinnant made a motion to approve the agenda, which was seconded by Commissioner Bryant, all approved.
